#### Summary of Responsibilities:

The Project Coordinator will be working at the field level and will be primarily responsible for the prison intervention-related activities in the assigned district(s). The position will report to the State Project Manager, who will be responsible for taking care of the Prison Intervention in the respective State. The below given is the base location and specific areas to be covered by each Project Coordinator. The number of Prisons & OCS will vary in each location.

#### Specific Responsibilities:

- Sensitize prisons and OCS officials about the health rights of inmates and the various services provided under the programme.
- Implement programme activities and achieve the programme targets in their respective P&OCS.
- Select and train Prison Peer Volunteers (PPV), so that they are able to educate and motivate prison inmates to access project services and are also able to identify inmates with high risk behaviour / vulnerabilities.
- Coordinate with district health functionaries and other stakeholders to ensure their support in providing HIV, TB, STI, HCV and HBV testing and treatment services to the inmates.
- Organise HIV, TB, STI, and HCV screening camps in coordination with local stakeholders (SA-ICTCs, DTO, DSRC, and NVHCP officials)
- Coordinate with P&OCS and district health authorities towards ensuring all inmates diagnosed with HIV, HCV, HBV, TB, and STI are initiated on treatment
- Coordinate with the PPVs towards motivating the HIV+ inmates to give consent to visit their families

- Coordinate with CLH to ensure home visits for motivating spouses and family members of HIV+ inmates to - (a) access HIV testing and treatment services, and (b) social protection services.
- Coordinate with CLH to ensure all released HIV+ inmates are adhering to treatment.
- Ensure accurate and timely submission of reports from the P&OCS to SACS.
- Complete the reporting requirements to the State level team, maintaining quality and within the timeline.
- Implement programme activities and achieve the programme targets in their respective P&OCS.
- Select and train Prison Peer Volunteers (PPV) so that they can educate and motivate prison inmates to access project services and identify inmates with high-risk behaviour/vulnerabilities.
- Strictly follow the organisational work plan and individual activity plan.
- Undertake other responsibilities not outlined above, which are commensurate with a role of this nature in the not-for-profit sector, which has been discussed and agreed upon between the line manager and the post holder.

- 3 to 5 years of relevant field-level experience in the Health domain at the district level.
- Specific experience working on HIV/AIDS-related programming on Prevention, Care & Support will be an added advantage and given preference. Similarly, experience working in Prison intervention programmes will also have an added advantage.
- Experience in direct programme implementation and interface with vulnerable and marginalised populations.
- Experience providing technical support to and capacity-building at the field level, especially those working at the community or grassroots level.

- Demonstrated knowledge and understanding of project management.
- Sound understanding of NGO/CBO support principles in the context of key populations' public health and human rights dimensions.
- Commitment to FSW / LGBT / IDU rights and inclusion and rights-based responses to HIV and generally to the key populations affected by the epidemic.
- Strong commitment to teamwork, collaboration, consensus building and negotiation.
- Highly passionate about his/her work with strong community engagement skills.
- Sensitive to Gender issues
- Ability and willingness to undertake travel within the assigned district(s) for an average of 50% to 70% of the time.
- Basic report writing skills.
- Fluency in the local language of the State(s) where the programme is being implemented is a must.

- Good understanding of development issues and the HIV epidemic(s) in India.
- Experience working in Global Fund supported programmes
- A good understanding of legal and ethical issues around HIV/AIDS/ KPs.
